The Anthony P. Trivisono Intake Service Center (ISC) is a maximum security facility which serves as Rhode Island's jail for male offenders. Rhode Island is one of six states that have unified systems, incorporating the jail and state prison into one department. The south side of the facility was constructed in 1982, while the north wing was constructed in 1992.

Inmates housed at the ISC fall into several categories: pretrial detainees, newly sentenced inmates who are awaiting classification to other facilities and sentenced protective custody.

Staffing at the facility consists of: 1 Warden, 2 Deputy Wardens, 1 Executive Assistant, 1 Security Specialist, 1 Maintenance Supervisor, 1 Inspector, 1 Investigator, 3 Captains, 13 Lieutenants, 2 Records & ID, Captains, 7 Records & ID Lieutenants, 2 Office Managers, 5 Data Clerks, 216 Officers, 5 Kitchen Stewards, 2 Teachers, 1 Parenting Coordinator, 7 Adult Counselors, 1 Chaplain and assigned Discharge Planners.

Intake Service Center provides seven day a week medical and mental health services for offenders within the facility.

There is: Doctor, 1 Nurse Practitioner, 1 Nursing Supervisor, 19 Nurses, 3 Psychiatrists, 1 Clinical Social Worker, 3 Physical Therapists, 1 Occupational Therapist, 2 Dentists, 2 Dental Hygienists and 3 Dental Assistants. In addition, there are several specialty clinics that are provided within the facility.

In FY22, the average age of a sentenced release who expired their sentence from Intake Service Center (excluding those admitted as parole violators) was 36 years old. The average length of stay was 53.6 days. Nearly 52% had a length of stay of 30 days or less. An additional 38% of sentenced releases had a length of stay between 1 to 3 months. Sentenced offenders were released after serving time for the following most serious offense types: non-violent offenses (59%), violent offense (36%), and drug related offenses (4%), 52% have completed High School with a diploma or obtained a GED, 83% are single, 42% reported to have been unemployed, with average of two children. The majority of sentenced releases were White (50%), Black (26%), Hispanic (20%) and other (1%)

In FY22, the average age of a pre-trial release was 36 years old. For all pre-trial releases in FY22, the average length of stay was 27.5 days. Nearly 54% had a length of stay of 7 days or less. Pre-trial offenders were released after being charged with the following most serious offense types: violent offense (45%), drug related offenses (14%) and non-violent offences (30%), 52% have completed High School with a diploma or obtained a GED, 80% are single, 38% reported to have been unemployed, with average of two children. The majority of pre-trial releases are White (48%), Black (26%), Hispanic (22%) and other (2%).

Staff at the facility is aware of the Department of Corrections' philosophy of encouraging offenders to have regular social visits with relatives and others in order to maintain close family ties and other positive relationships and support systems. Visits are offered three (3) times a week for each offender.
