Facility Dress Code: NO low cut, sleeveless or hooded garments - No athletic wear to include jogging suits - sweatpants - yoga pants – leggings. No ripped or torn clothing - No military or law enforcement style clothing to include camouflage - No nursing uniforms “scrubs” - No slip-on, open toe, or open back shoes - No jewelry except for wedding & engagement rings. – Or any clothing deemed as inappropriate or provocative by Correctional staff.

Court Clothing: Clothing is accepted seven (7) days a week between 7:30 a.m. - 7:00 p.m. Items NOT accepted are: Socks, Ties, Belts or Undergarments – No sneakers, boots or sweat suits No suede or leather jackets or jackets with hoods. **No Clothing Will Be Accepted on the Day of Court.**

Personal Property: Non mailed personal property can be picked-up at Intake Reception between 7:30 a.m. and 7:00 p.m. - 7 days a week. After a 30-day period non-mailed property may be destroyed.

Visitation: All visitation is per the schedule except for visitors that reside at least 75-miles from the Intake Service Center – A valid out of state ID is required for any out-of-state off schedule visits.
