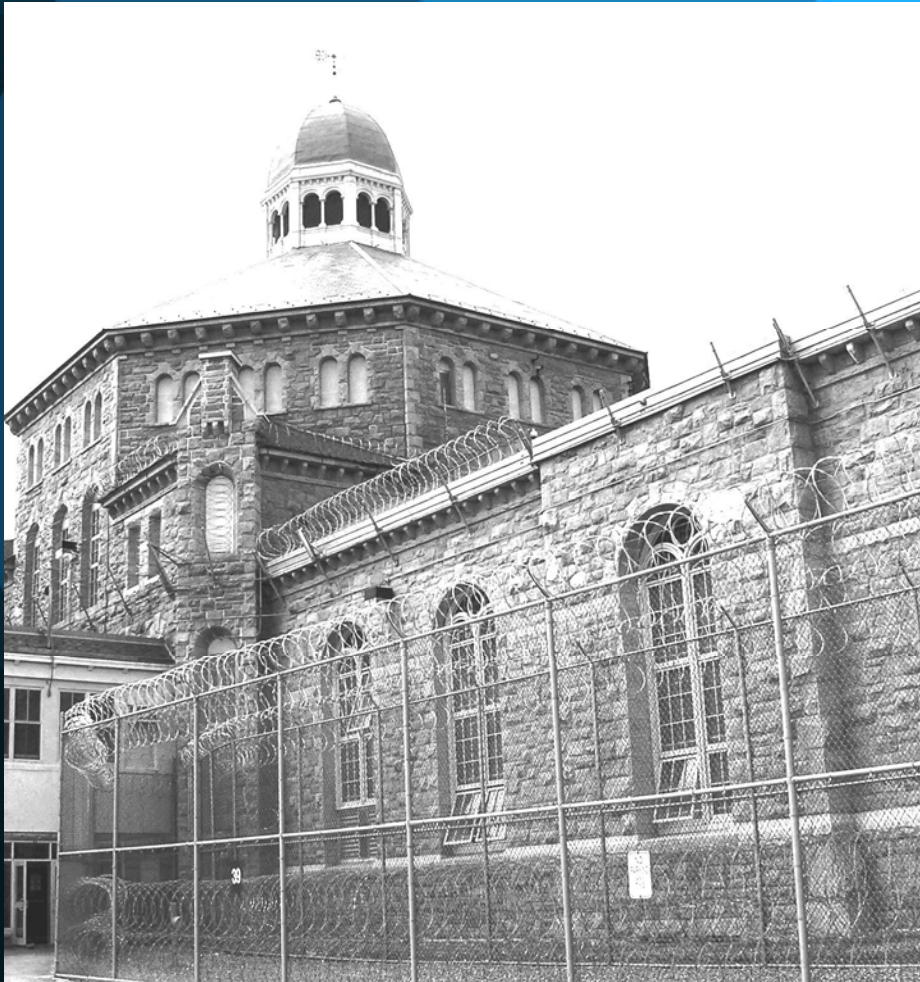

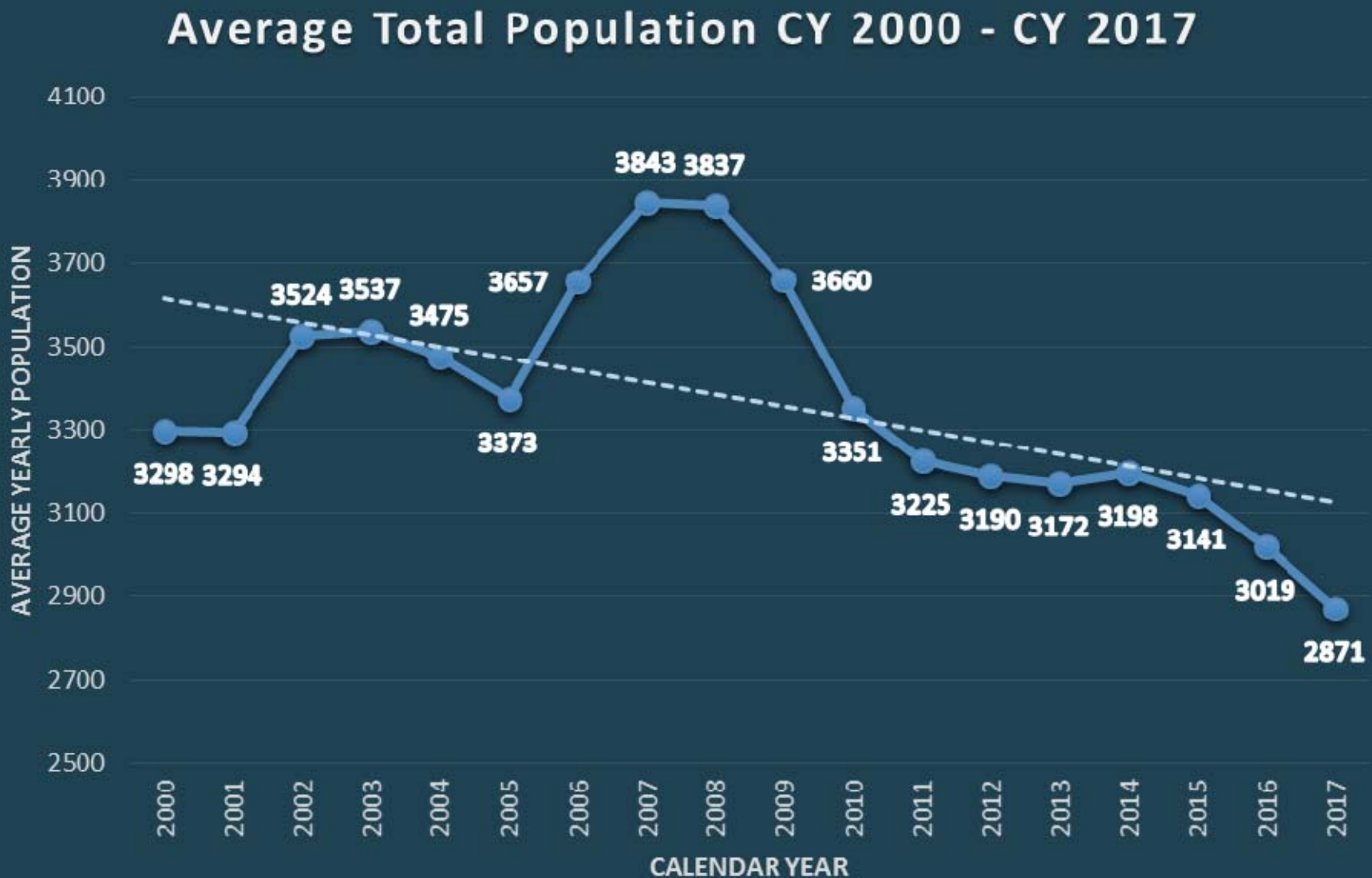

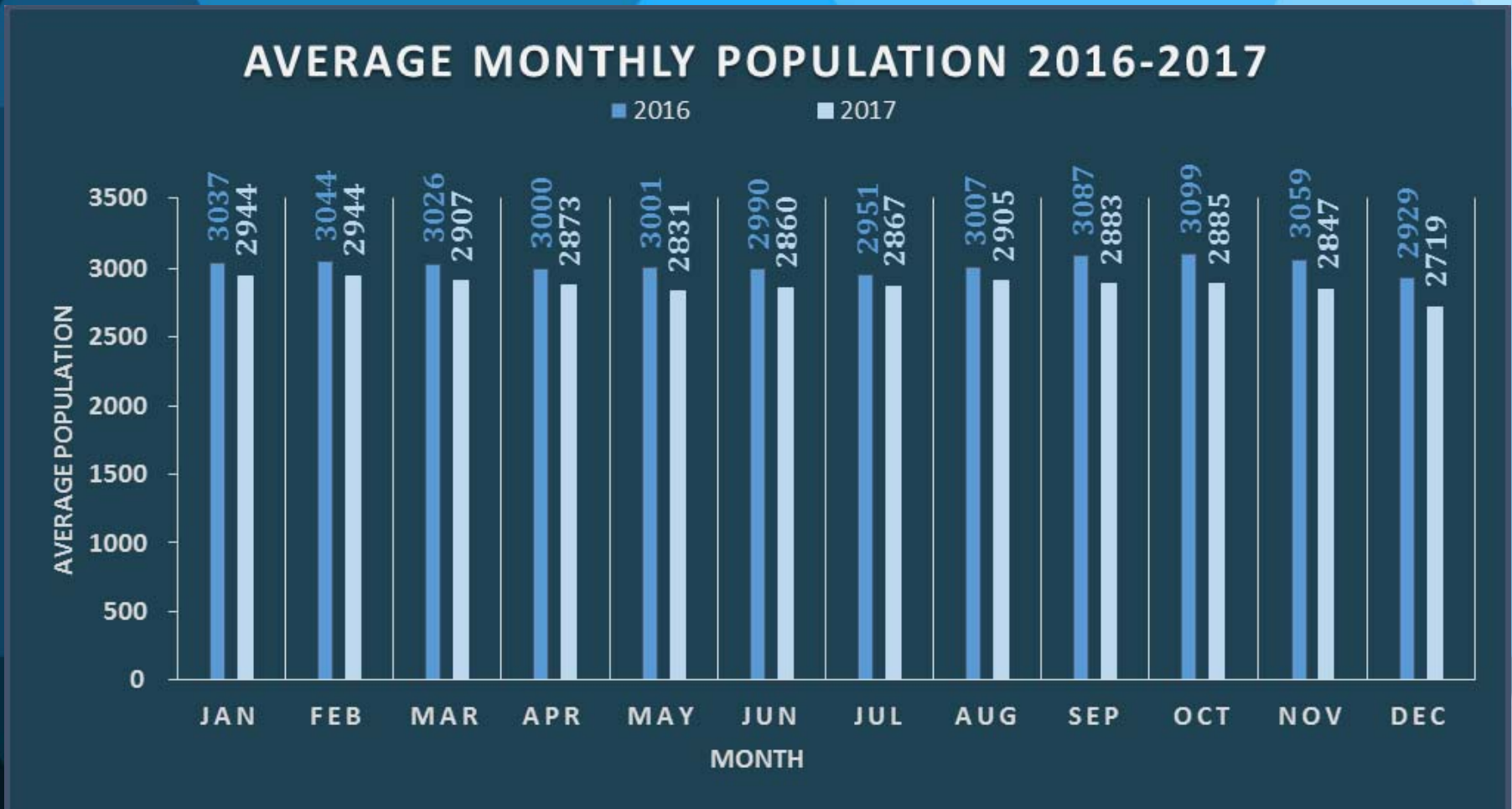


AVERAGE TOTAL POPULATION CY 2000 TO CY 2017





AVERAGE TOTAL POPULATION BY MONTH CALENDAR YEARS 2016-2017

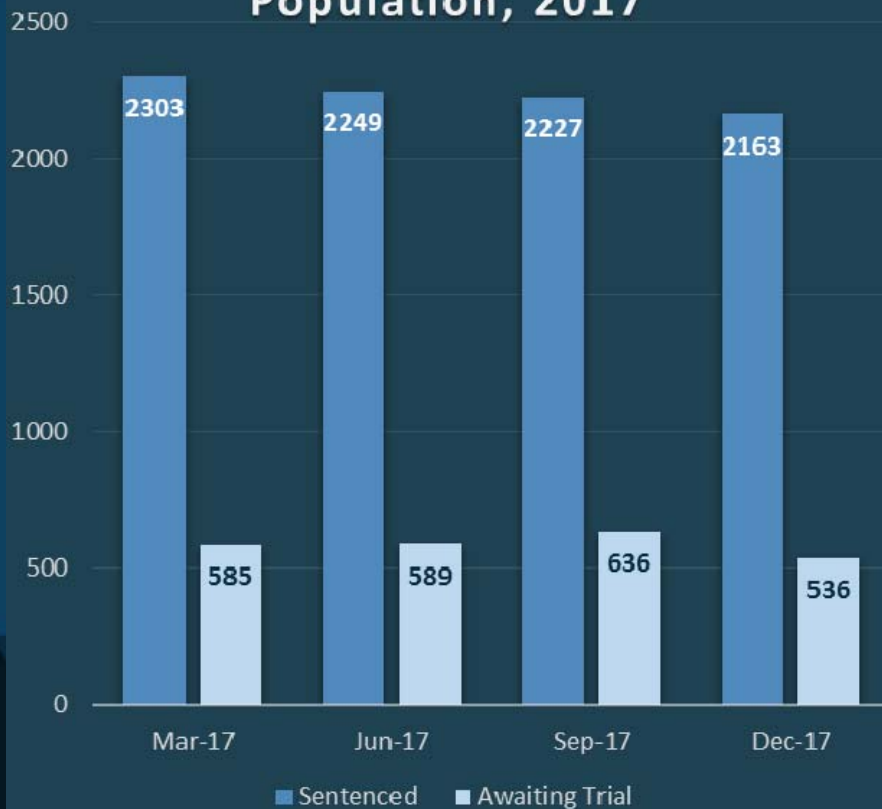


Every month in CY17 had a lower average monthly population than CY16.

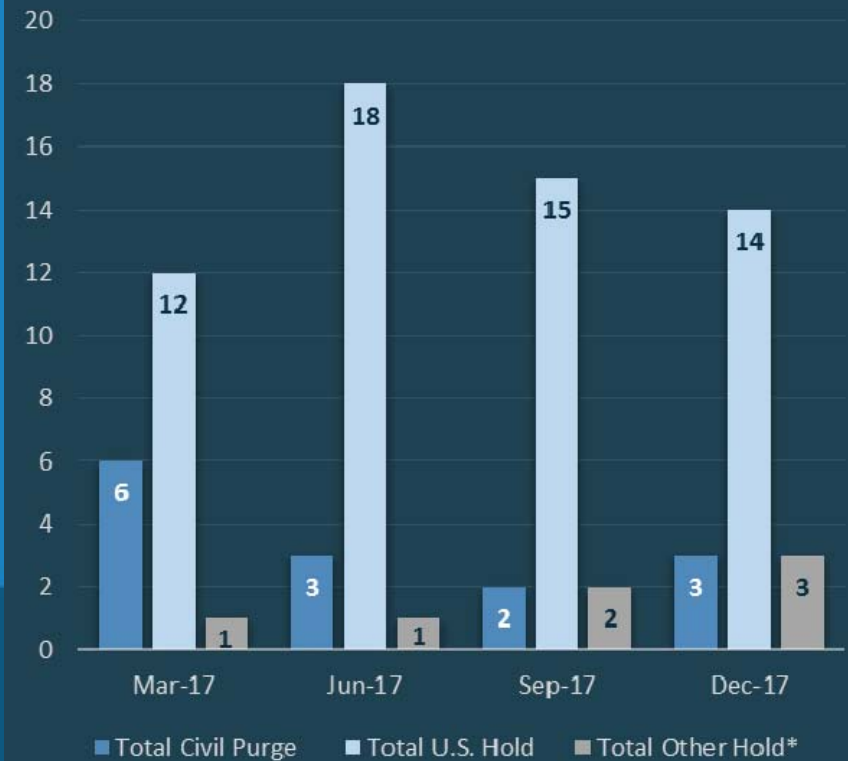


CY17: SENTENCED & AWAITING TRIAL, CIVIL PURGE & DETAINEES

Average Quarterly Sentenced and Awaiting Trial Population, 2017



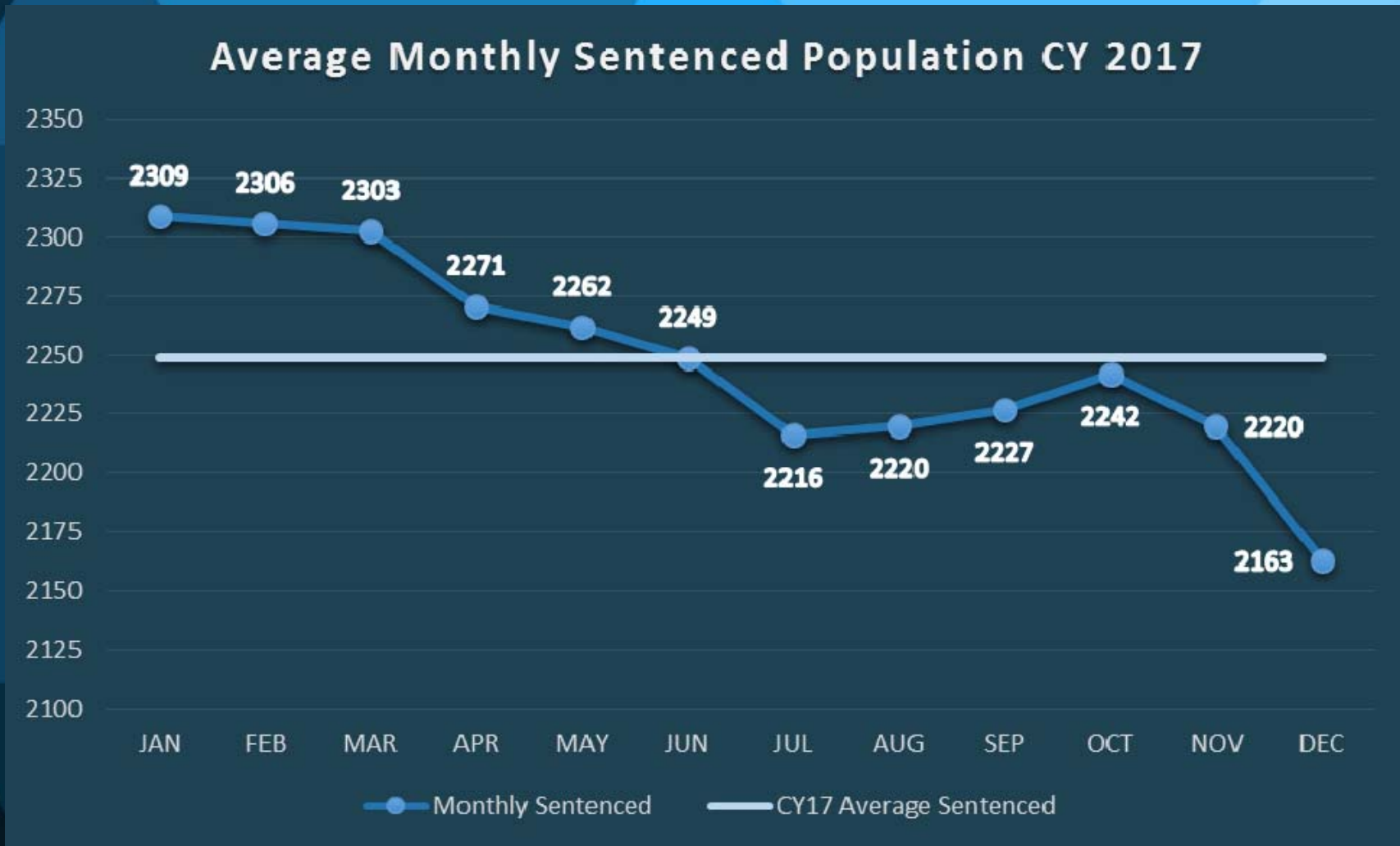
Average Quarterly Civil Purge & Detainees Population, 2017

AVERAGE MONTHLY SENTENCED POPULATION CALENDAR YEAR 2017

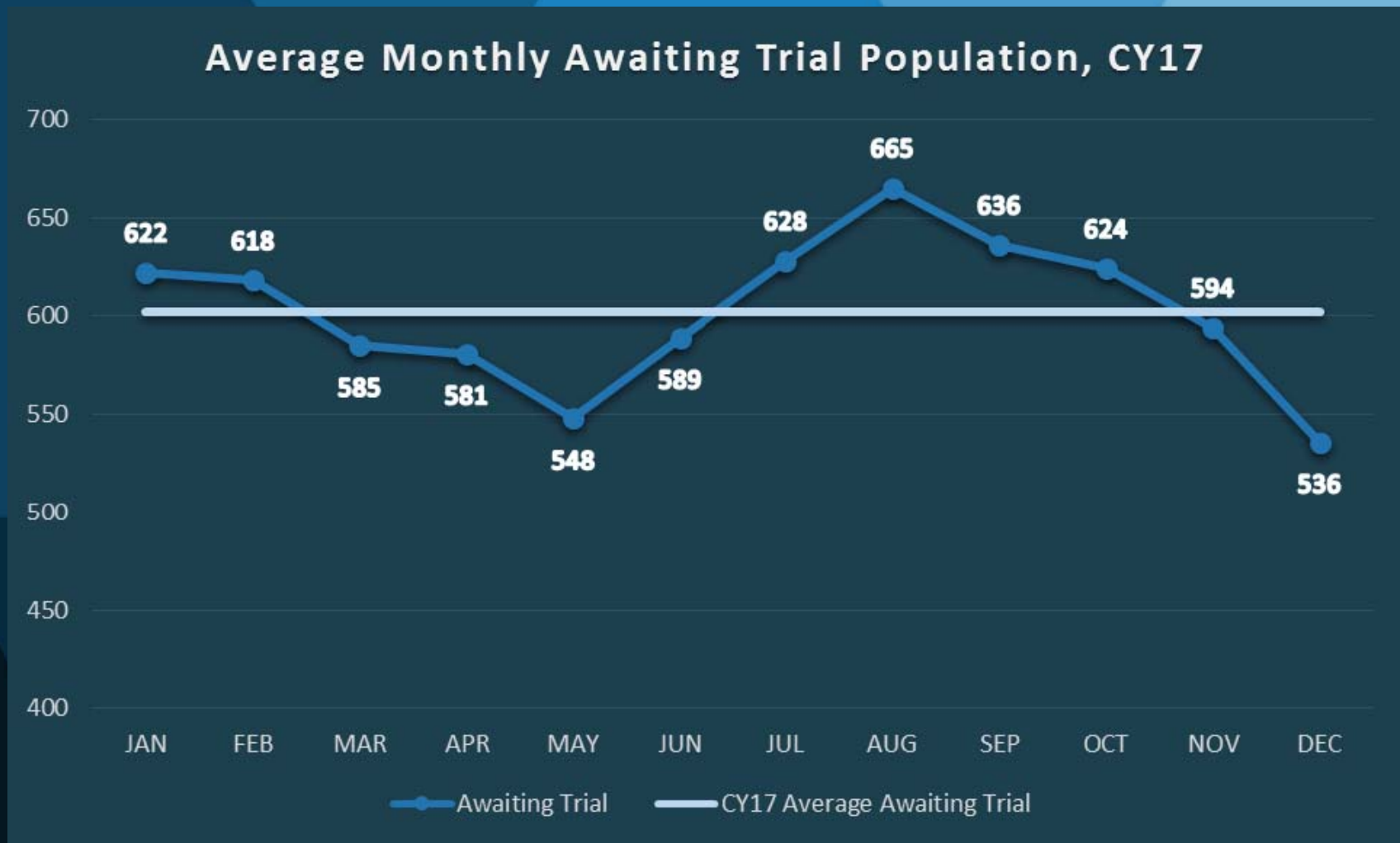


The Average Sentenced Population decreased 6.3% from the beginning of CY17 to the end.



AVERAGE MONTHLY AWAITING TRIAL POPULATION CALENDAR YEAR 2017

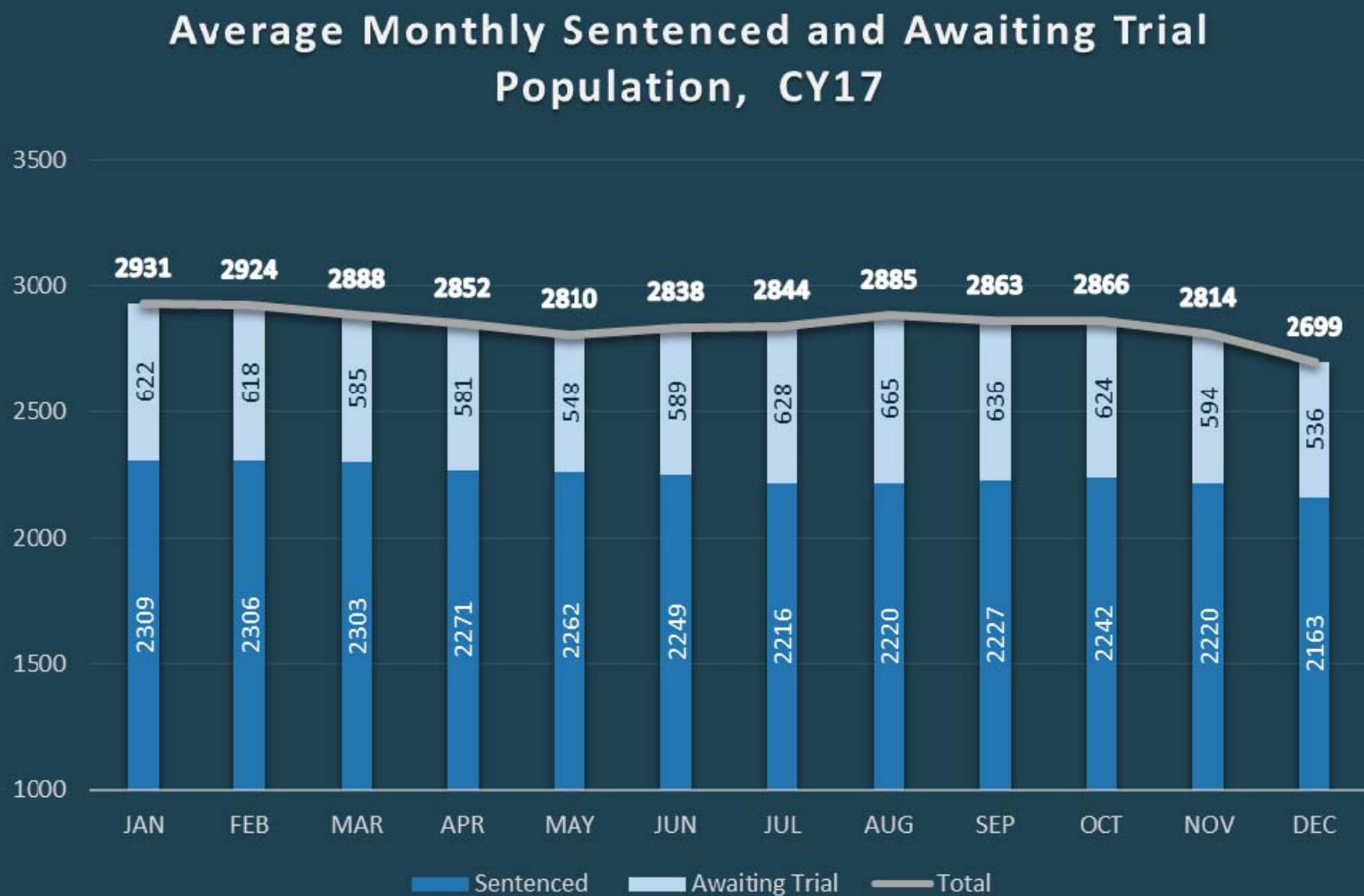
The Average Monthly Awaiting Trial Population increased from 574 in CY16 to 602 in CY17, an increase of 4.9%.

The Average Monthly Sentenced Population for CY17 was 2249 and the Average Monthly Awaiting Trial Population for CY17 was 602.



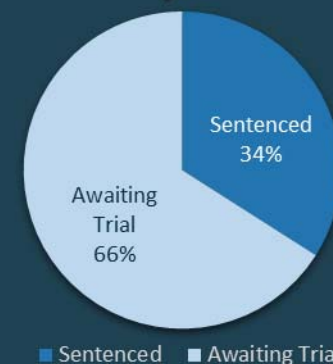

RIDOC TOTAL COMMITMENTS CY 1997 – 2017

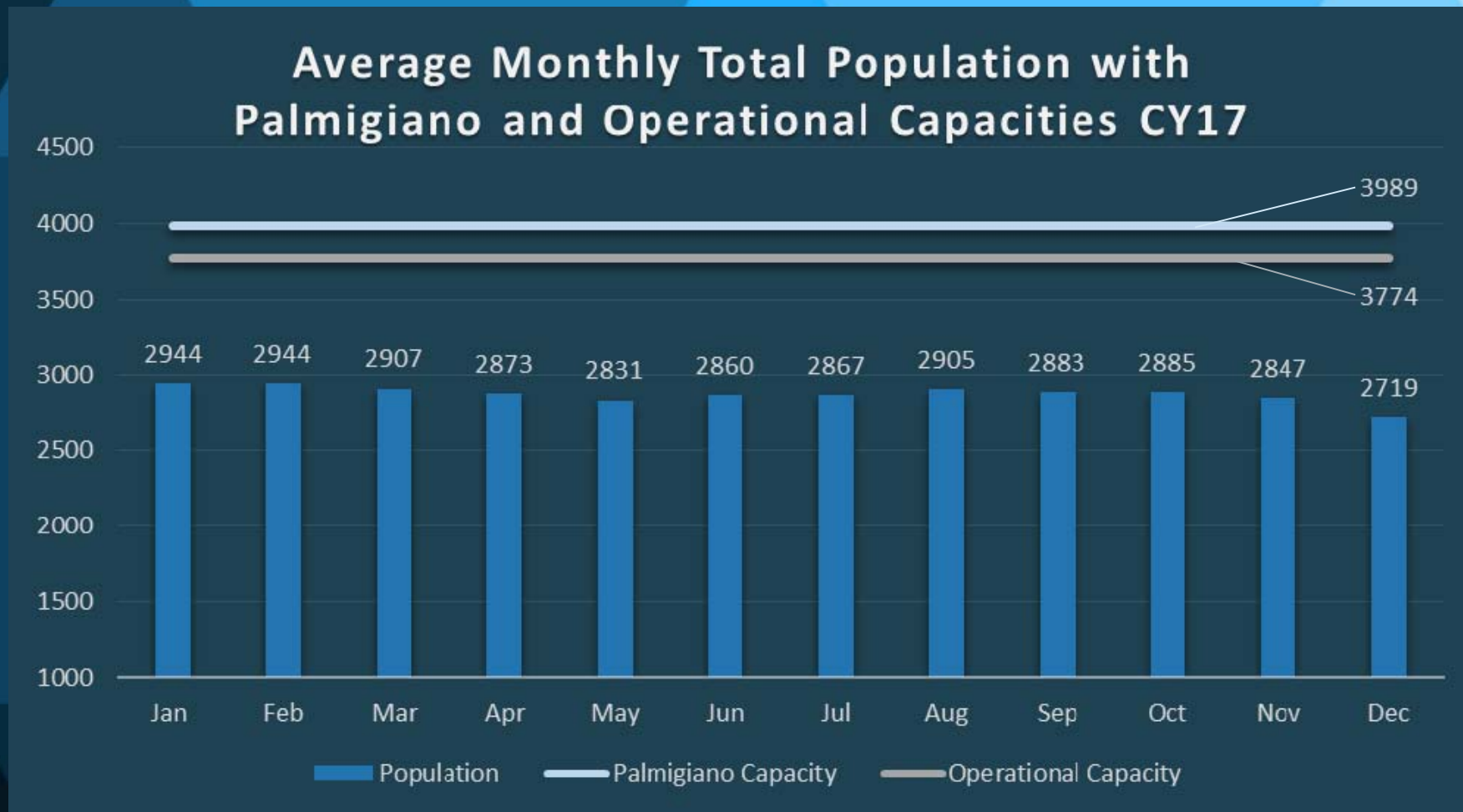
The Total Commitments for CY17 were 13047 which is the lowest point in 20 years.

POPULATION VS. OPERATIONAL & FEDERAL CAPACITY CY 2017



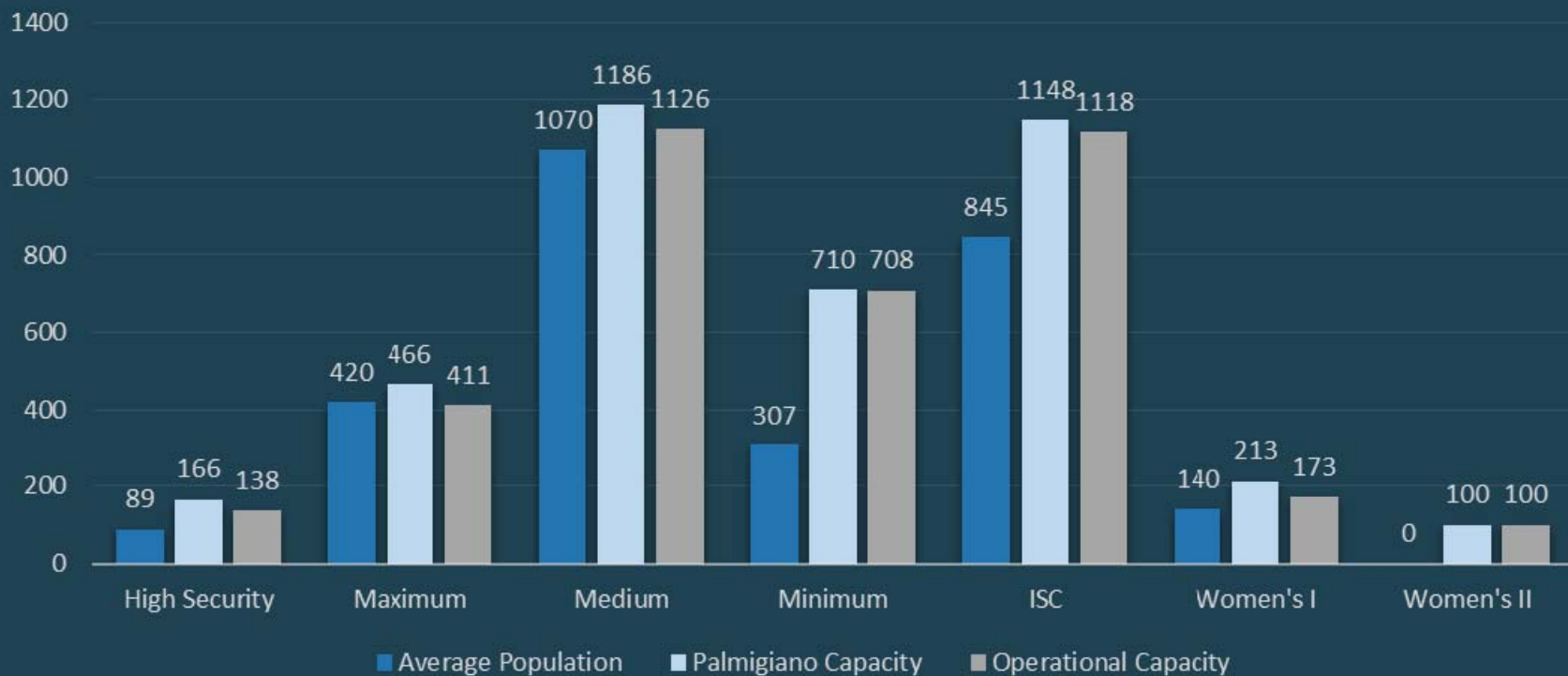
Total Average Population for CY 2017 = 2871

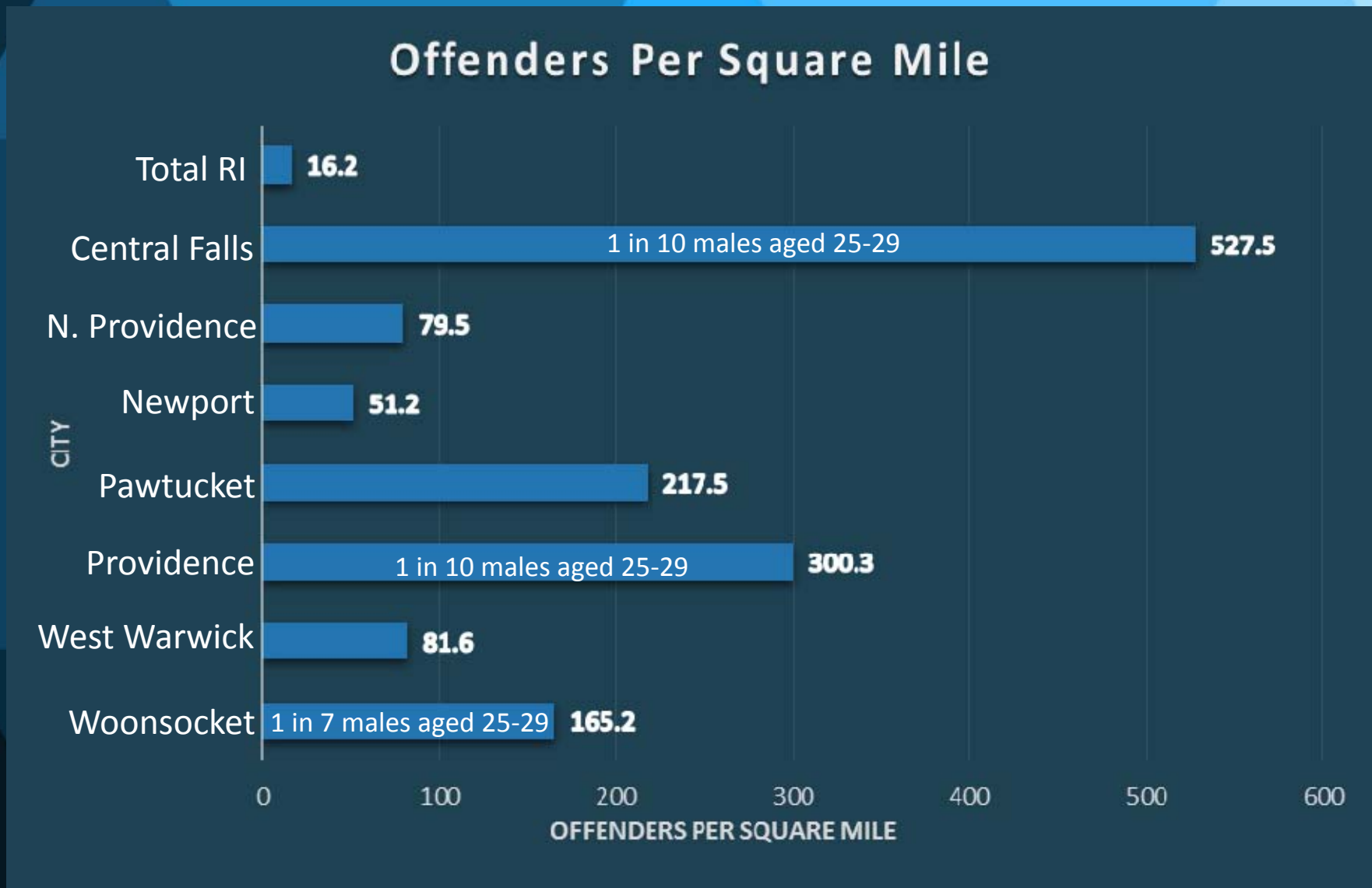

NUMBER OF OFFENDERS ON COMMUNITY SUPERVISION PER SQUARE MILE AS OF DECEMBER 31, 2017

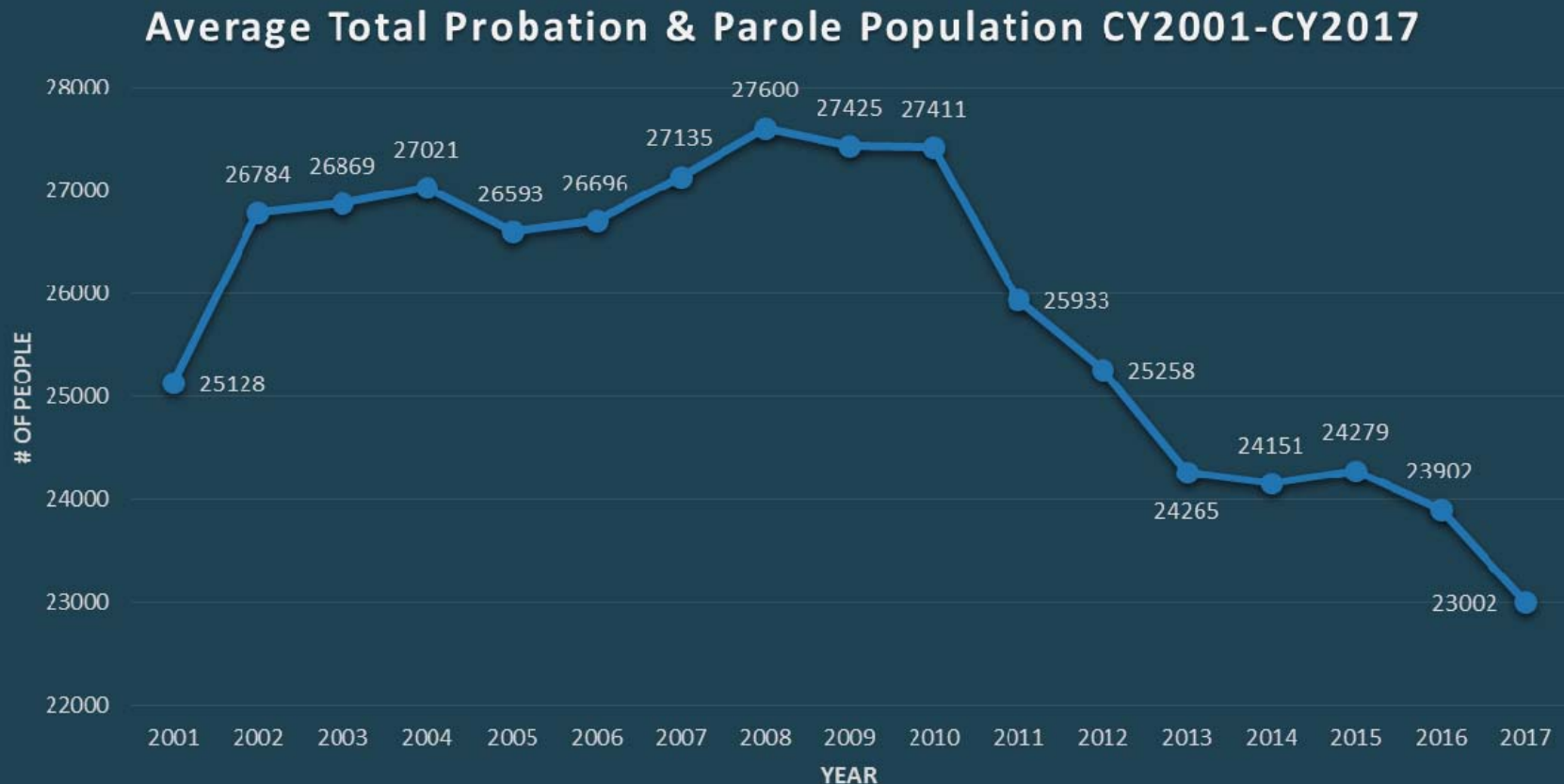


1 out of every 49 adult residents in RI is on probation or parole.

1 out of every 28 men and 1 out of every 147 women in RI is on probation or parole.



AVERAGE TOTAL PROBATION & PAROLE POPULATION CY 2001 TO CY 2017



Total population includes active, low and banked supervision cases.

As of December 31, 2017, there were 22,974 RI offenders on Adult Probation & Parole.

Of those:

8,219 were on Active Supervision

2,021 were on Low Supervision (offenders who have at least one open indictment, but are NOT reporting to or in regular contact with a probation or parole officer)

12,734 were Banked Cases (not actively supervised includes Superior and District Court banked, active warrant, trouble free, incarcerated, court-ordered unsupervised, pending transfer, deported, paroled to immigration and pending interstate cases)

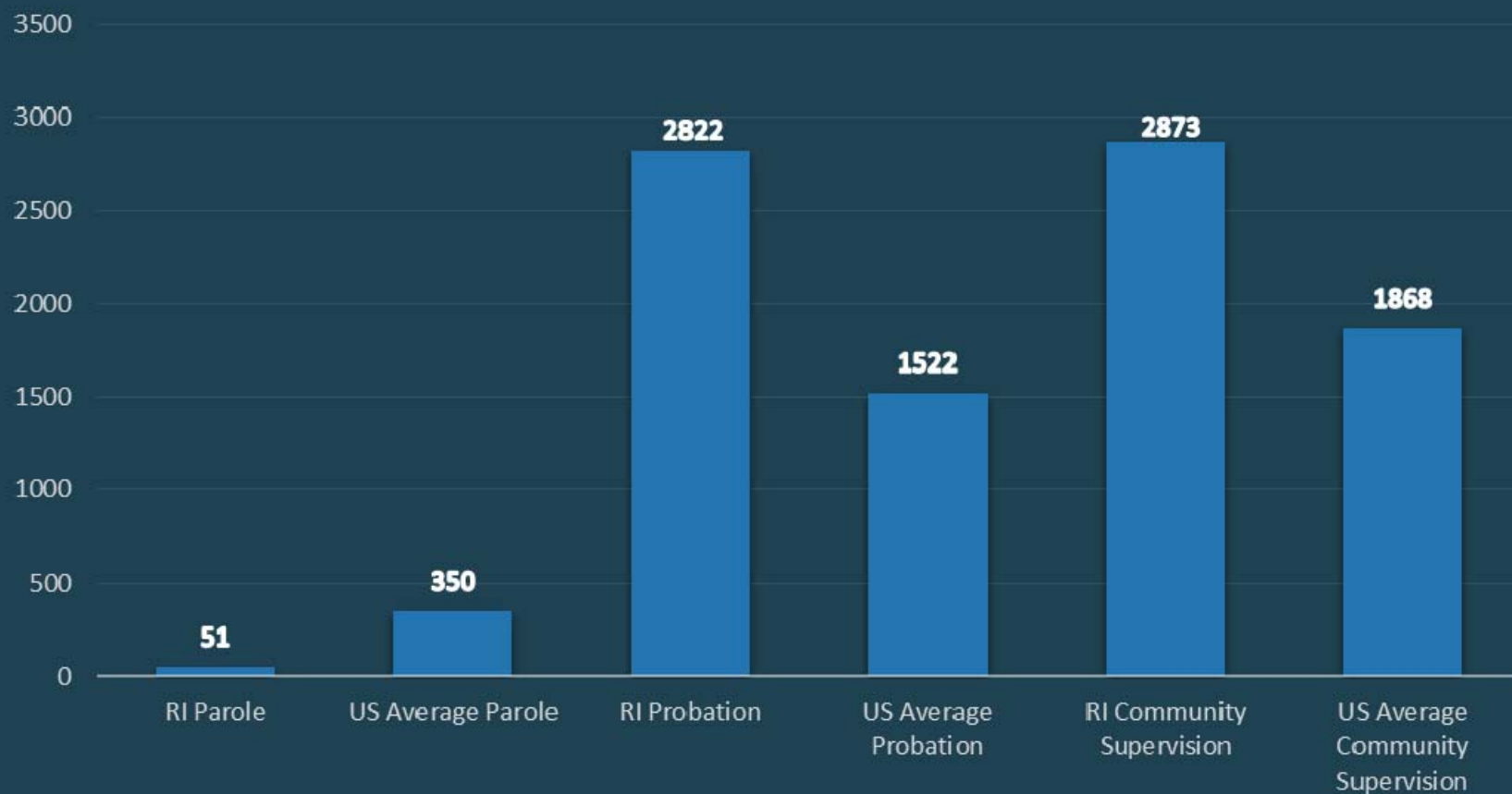

HOW DOES THE RI COMMUNITY SUPERVISION POPULATION COMPARE?

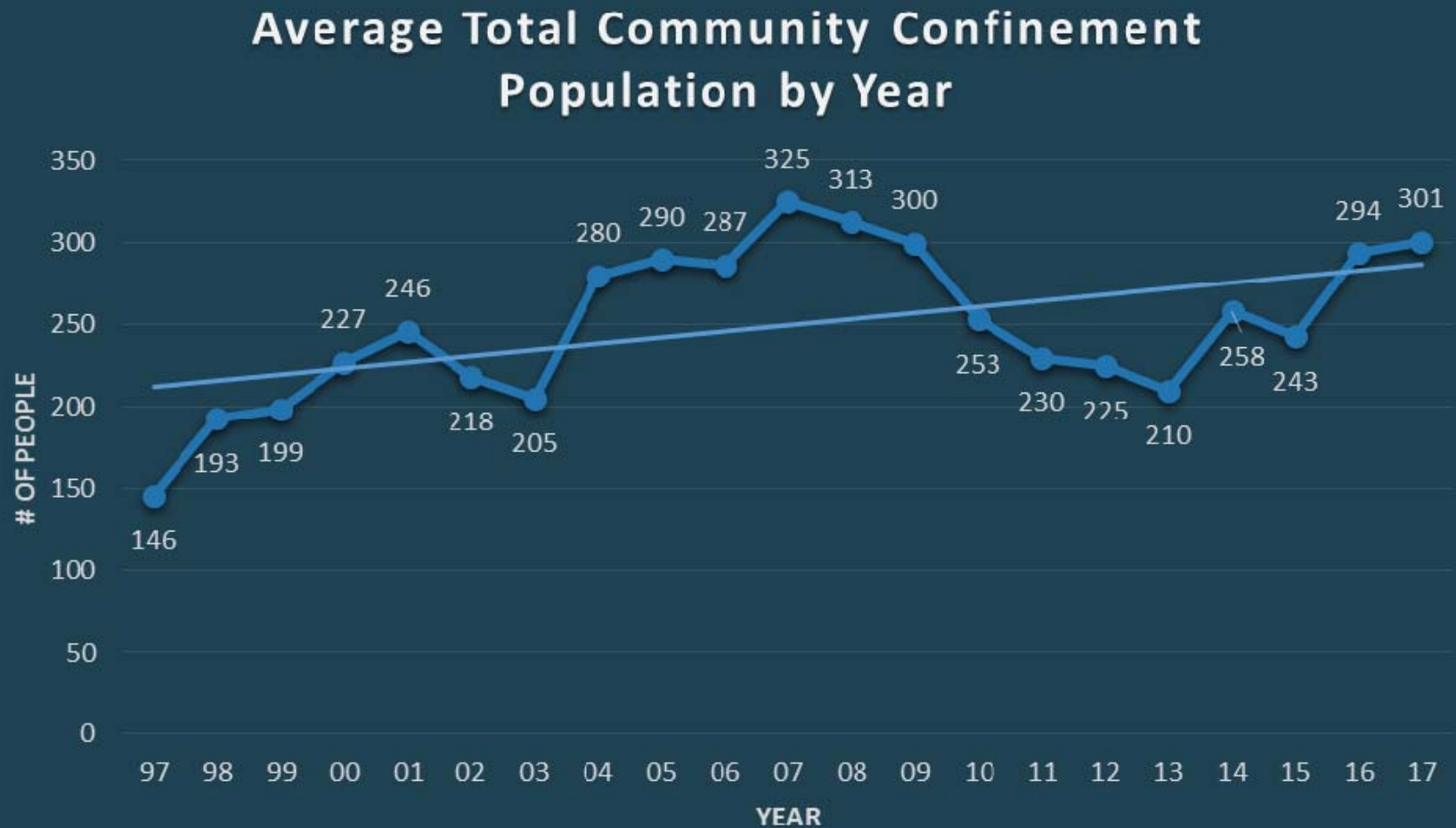
RI and US Parole, Probation and Total Community Supervision per 100,000 Residents

There has been a 106% increase over the past twenty years in this population.



RI INMATES SERVING LIFE OR LIFE WITHOUT PAROLE

- As of December 31, 2017 there were 31 Rhode Island inmates serving a sentence of Life without Parole (4 were serving out-of-state).
- As of December 31, 2017 there were 208 Rhode Island inmates serving a Life Sentence* (22 were serving out-of-state and 2 were Dual Lifers).

* this total **excludes** 13 Out of State Lifers (OOS Lifer) serving another state's sentence in RI according to interstate compact and **includes** Dual Lifers which are inmates serving multiple states' sentences
